All unsold wash books and final payment must be returned to Lucas Oil Center within 10 business days of completion of fundraising period. A valid credit card will be required to release books to the Organization. Card on file will be charged for the full amount (\$25.00/book) if unsold books and/or payment are not received within 10 business days of completion of fundraising period or if books are damaged. Under no circumstance are fundraising wash books to be sold or distributed on Lucas Oil Center property, parking lot/area adjacent to, or vicinity of.
